Reorganization

Effective April 1, 2019

Reorganization of Suntory Spirits Limited

To strengthen the spirits business, the Whisky Department will be restructured into a new Whisky Marketing Division. Additionally, the RTD Marketing Department and Liqueur / Spirits / Shochu Marketing Department will be integrated into a new RTD / Liqueur / Spirits / Shochu Marketing Division.
