#### Reorganization

#### Effective January 1, 2021

#### **Reorganization of Suntory Holdings Limited**

- Establish Group Strategy & Transformation Division to develop and execute the entire group transformation plan, aiming to the achieve continuous growth of the Suntory Group. Establish Business Strategy Planning Department under Group Strategy & Transformation Division and transfer the strategy planning function which belongs to Group Strategy Planning Department.
- Establish Digital Transformation Division and place DX Strategy Department and IT Strategy Department under Digital Transformation Division to enhance digital transformation of entire Suntory group. Transfer IT planning function which belongs to BPR & IT Planning Department and Suntory System Technology under IT Strategy Department.
- · Establish Corporate Planning & Administration Division and Corporate Planning & Administration Department, and transfer business planning and administration function which belongs to Group Strategy Planning Department and accounting function which belongs to Finance and Accounting Department into Corporate Planning & Administration Department and establish Finance Department under Group Strategy & Transformation Division. Establish BPR Department and transfer BPR function which belongs to BPR & IT Planning Department.
- Establish People & Organization Strategy Department under Human Resources Division, in order to accelerate transformation of our organization and culture strategy, aiming to achieve the continuous growth of the Suntory Group.

#### Reorganization of Suntory Beer, Wine & Spirits Japan Limited

• Reorganize Strategy Planning Department into Business Strategy Division in order to improve capability which plans and implements comprehensive Japanese liquor business strategy and its human development strategy.

#### **Reorganization of Suntory Spirits Limited**

- · Integrate Liqueur/Spirits / Shochu Marketing Department and Liqueur / Spirits Integrated Innovation Department in order to create new demand for liqueur spirits beyond the boundaries of liqueur categories and domestic / import.
- In order to improve the quality of the whisky liquid and strengthen the long-term supply and demand management, Whisky Development & Production Department will be newly established, divided from Production Department.

#### **Reorganization of Suntory Wine International Limited**

• Establish Winery Wine Business Division which covers own winery business and Imported & Domestic Wine Business Division which covers all the business aspect of Imported and Domestic developed wine. Establish Production Department under Winery Wine Business Division and all the own wineries will be positioned under Production Department.

#### **Reorganization of Suntory Liquors Limited**

- · Integrate Sales Development & Marketing Promotion Division and Marketing Planning Division Dismantle Marketing Planning Division and integrate it into Sales Development & Marketing Promotion Division in order to further improve management speed and execution, carrying out all at once from mid-term strategy planning to execution, promotion, and business management of domestic liquor sales.
- Establishment of E-Commerce Sales & Marketing Division Spin off EC section which is placed at Nationwide Chainstores Marketing Division and establish E-Commerce Sales & Marketing Division to accelerate sales growth in the rapidly growing EC market.
- Transfer Yamanashi Branch from Metropolitan Sales & Marketing Division to Sales & Marketing Division Kanto Shinetsu Area. Change the name of Sales & Marketing Division Kanto Shinetsu Area to Sales & Marketing Division Kanto Koushinetsu Area.
