Reorganization of Suntory Holdings Limited

- To strengthen Suntory Group's mid-to-long-term strategic planning and global CoE (Center of Excellence) functions in manufacturing, MONOZUKURI Division and Suntory MONOZUKURI Expert Limited will be integrated and reorganized into three new divisions: Group Quality Assurance Division, MONOZUKURI Center of Excellence Division, and Supply Chain Division. - We will also integrate and reorganize Corporate Brand Strategy Department with Advertising Department, Design Department, Consumer-Oriented Management Division and Business Planning Department of Suntory Communications Limited and establish a new Communication Design Division, with the aim of further developing the corporate brand globally, strengthening cooperation with each business, and promoting activities that mutually enhance the value of domestic and overseas product brands. Corporate Brand Strategy Department, Advertising Department, Design Department, Consumer-Oriented Management Department, and Business Planning Department will be placed under Communication Design Division.
- Global Public Relations Department will be integrated into Public Relations Department.
- We will establish MBC (MONOZUKURI-based Brand and Culture) Laboratory to vigorously promote quality improvement for spirits, wines, and other products belonging to the Suntory Group and enhance the value of the brand experience at MONOZUKURI Gemba.
