This is to notify that Suntory Holdings Limited will be reorganizing group companies and implementing their executive appointments.

#### Reorganization

#### Effective March 1, 2022

#### **Reorganization of Suntory Holdings Limited**

- · In order to accelerate personnel, organizational, and environmental reforms toward the continuous growth of the Suntory Group, the Human Resources Division will be renamed the People & Culture Division. Its subdivisions, the Global Human Resources Department and Diversity Promotion Section, will be renamed, respectively, the Global People & Culture Department and the DEI (Diversity, Equity & Inclusion) Promotion Department.
- In order to reinforce the management system integrating personnel and labor duties, the Human Resources Department, People & Organization Strategy Department, and Career Planning & Development Department will be merged into the People & Culture Division.
- In order to achieve effective promotion of risk management activities throughout the Suntory Group overall, a Risk Management Planning Department will be created within the Risk Management Division.
- In order to achieve integrated promotion of the Suntory Group's participation in Expo 2025 Osaka, Kansai, the EXPO 2025 Osaka, Kansai, Japan Preparation Department will be newly established.
- In order to reinforce digital and IT activities overall, Suntory System Technology Limited will be placed directly under the Digital Transformation Division.

#### **Reorganization of Suntory System Technology Limited**

The infrastructure function of the Global IT Service Department will be transferred to the IT Infrastructure Service Department, and the information security function to the IT Strategy Department of Suntory Holdings Limited. Accordingly, the Global Services Department will be abolished.

## Reorganization of Suntory Beer, Wine & Spirits Japan Limited, Suntory Spirits Limited, and Suntory Beer Limited

In order to reinforce effective communication with the media, etc., from the perspective of the liquor business overall, a Communication Department will be established within Suntory Beer, Wine & Spirits Japan Limited.

Accordingly, the Advertising & Planning Departments of Suntory Beer Limited and Suntory Spirits Limited will be abolished.

#### **Reorganization of Suntory Spirits Limited**

In order to proceed more effectively with RTD global development, the Global RTD development department will be established.
