#### Effective January 1, 2023

### **Reorganization of Suntory Holdings Limited**

- The Group Strategy & Transformation Division will be renamed the Corporate Planning Division to carry out group-wide reforms. In addition, the group management promotion function of the Corporate Planning & Administration Division will be transferred to the Corporate Planning Division.
- The Intelligence Division will be newly established to gather information on political and economic trends for global growth and to strengthen internal collaboration and networking with external organizations in major countries.
   The Economic Intelligence Management Department will also be transferred and placed under the Intelligence Division.

### **Reorganization of Suntory Wellness Limited**

- The Business Planning Department will be renamed the Business Planning Division to strengthen the corporate planning and cross-regional functions.
- In order to build an integrated business system based on brand and customer service, the Health Care Department, Skin Care Department, and Service Department will be newly established.
- As such, the Brand Development Department, Brand Strategy Department, Beauty Department, and Customer Service Strategy Department will be abolished. Also, the production function of the Brand Strategy Department will be transferred to the Media Department, which will be renamed the Media Production Department.
